

Mitchell College Off-Campus and Out of State Travel Policy*

**Subject to change*

▶ ALL RESIDENT STUDENTS

The College strongly discourages non-essential off campus travel for resident students until further notice.

▶ ALL RESIDENT & COMMUTER STUDENTS

All students should avoid traveling out of state until further notice.

All students should avoid traveling anywhere off campus – whether in state or out of state – to spend time with any persons who are currently sick, quarantining or awaiting COVID test results.

▶ COMMUTER STUDENTS LIVING OUT OF STATE

Students who live in another state and travel to campus for classes should continue to follow the Mariner Promise. When leaving their home state other than to attend class on the Mitchell College campus, they must comply with the following travel policy and procedures.

LEAVING THE STATE

Students **who choose to travel** out of the State of Connecticut (or for commuters, out of their home state) and are gone for more than 24 hours, must comply with the following procedures according to where they have traveled (Non-Affected State or Affected State as defined by the State of Connecticut.)

Non-Affected State <i>Link to States ></i>	Travel Over 24 Hours
Document Travels	Submit College Travel Acknowledgment Form using password: Mariners2020
Symptom Check	Do not return to campus if you are experiencing any symptoms of COVID-19 (https://www.cdc.gov/coronavirus/2019-ncov/symptoms-testing/symptoms.html) or were, in your travels, knowingly exposed to anyone diagnosed with COVID-19, quarantining or awaiting COVID-19 test results.
Pre-Arrival Test	In some cases, you may be asked to submit a pre-arrival test before returning to campus
On-Campus Test	Students who travel out of state will be added to the COVID testing pool upon their return at the discretion of the College.
Self-quarantine	No self-quarantine required with submission of negative test result.

Affected State Link to States>	Travel Over 24 Hours
Document Travels	Submit College Travel Acknowledgment Form using password: Mariners2020
Symptom Check	Do not return to campus if you are experiencing any symptoms of COVID-19 (https://www.cdc.gov/coronavirus/2019-ncov/symptoms-testing/symptoms.html) or were, in your travels, knowingly exposed to anyone diagnosed with COVID-19, quarantining or awaiting COVID-19 test results.
Pre-Arrival Test	In some cases, you may be asked to submit a pre-arrival test before returning to campus.
On-Campus Test	Upon return to campus, student must immediately contact Health & Wellness at healthservices@mitchell.edu to let them know of student's return. Health & Wellness will contact student to schedule an on-campus COVID test. Student should not schedule this test themselves.
Self-quarantine	Student must self-quarantine upon return to campus UNTIL they have received their on-campus COVID test results. If the on-campus test is negative, student may end this self-quarantine. If the on-campus test is positive, students must begin self-isolation .
State Requirement	Student must also complete the Connecticut Travel Health form and provide negative COVID results to the Department of Public Health Commissioner.
